SUBJECT: DigiLab Update

**BACKGROUND:** Thirty of SCLC's 39 member libraries participate in the DigiLab program, which provide participants with scanning equipment, license access to the Auto-Graphics Montage digital archive application and the necessary training to digitize materials in their local collections and store them in a hosted, publicly accessible environment. Twelve of the participants are currently uploading content to the Montage solution.

Technology Committee members will be provided with an overview of the program, current participants will be invited to relate their experiences, and non-participants will be invited to express interest in participating in a future funding round.

SUBJECT: SCLC Shared eResource Recommendations

BACKGROUND: On September 30, 2020 a survey was distributed to members of the SCLC Technology Interest Group seeking input on the types of eResources the member libraries would be interested in adopted if licensed through an SCLC member-wide agreement using CLSA funds. As of October 21, 2020, there were fourteen responses. Areas of interest cited were:

- eBooks (7 votes)
- eNewspapers (4 votes)
- Streaming movies (2 votes)
- eMagazines (2 votes)
- Streaming music
- Student resources
- eAudio
- Kanopy streaming
- eLearning solution (e.g. LinkedIn Learning)

Regarding eBooks, ten of the survey respondents noted that their library currently uses the Overdrive platform, five respondents noted use of the Bibliotheca Cloud platform, and one noted plans to migrate to Overdrive this year.

FISCAL IMPACT: None
