SUBJECT: Budget Status Report for FY 2024/25 (DISCUSSION)

BACKGROUND: Budget Status Report for FY 2024/25 is attached for review and reflects reconciled bank statements through August 31, 2024.

For revenues, membership dues of \$241,103 were recorded as financial resources available for use. Other revenues include communication and delivery of \$461,053, system administration of \$12,034, fiscal and administrative revenues of \$37,075 and grant revenues of \$141,690, which were recorded as respective expenses were recognized.

Expenses include communications and delivery of \$461,053, personnel expenses of \$308,304, and other administrative expenses of \$21,054. These expenses do not reflect what was paid but amounts that were incurred.

As of August 31, 2024, the System has a surplus of \$27,855 and cash balance and investments totals \$3,469,031.

The exhibit included with this report was prepared and submitted by Council Member Winslow for the Committee's consideration and discussion.

SCLC Executive Council Meeting

October 24, 2024

RE: Discussion about SCLC Employee Compensation and the Budget Status Report accuracy

At the Administrative Council meeting on August 22,2024, we were discussing the additional contribution to staff healthcare costs for 2025 as one agenda item. I made a comment that it was nice for SCLC only having to pay for one employee's medical plan and Christine Powers let us know that she and two other SCLC staff members received their healthcare spending but that it went into a 457 account for them. I have spoken to several other directors to see if they knew that three-fourths of the "Health insurance – current employees" line of the Budget Status Report is actually being put into 457 deferred compensation accounts, which is \$42,000 of the allocation for this fiscal year, and they did not know. I find this to be inaccurate reporting of how SCLC's budget is being spent. This is especially important as the budget has been very tight and we've had to make decisions about cutting where we can, such as the decision to reduce the retiree health care spending to the PEMCHA minimum back at our May 29, 2024 meeting.

I have exchanged several emails with Christine Powers (which Hilda, Mandy and Jesse were copied on) about this topic, and understand that each SCLC employee is contracted and may have made decisions about their employment with SCLC knowing they would be getting almost \$1000 a month into their deferred compensation retirement accounts. But this is not something that the Administrative Council was aware of when discussing raises or compensation during the Executive Director's evaluation process. As I pointed out to Christine, most government agencies that offered some type of compensation to employees that to do not take advantage of their healthcare allotment no longer offer a cash payment or 457 payments due to budgetary restrictions. I believe SCLC is no longer in a financial position to do so as well.

I realize that this would have to be renegotiated with SCLC employees when their contracts come up for renewal. I propose a few things that can be done ahead of any re-negotiations. These include:

Adding a separate line to the Budget Status Report that accurately reflects the
expenditure. I recommended a second line under "Retirement Contributions," so
there would be a line that is "CalPERS Contributions" and one that is "Deferred
Compensation Contributions" so we can easily see how the money is actually being
spent.

- 2. Review and revision the policies in the Employee Handbook. to consider no longer giving healthcare spending to future employees in the form of 457 payments as a standard rule.
- 3. At some point in the future, add a Closed Session agenda item to a future AC meeting to review and discuss current employee contracts and the negotiated benefit packages so both the EC and the AC have an understanding of employee benefits and how that looks in the budget each year.

I had a meeting with Hilda on September 11 to discuss the emails between Christine and me and next steps to address these concerns. She suggested I meet with the Executive Council at their next meeting and provide a report of my observations and proposed changes that could be made.
